Oral, facsimile, e-mail or telephone bids will not be accepted.
- 2. The bidder certifies his offer is "firm" for a period of 15 working days from award of bid.
- **3.** <u>REJECTION OF OFFERS:</u> The University of Kentucky, Surplus Property Department, reserves the unqualified right to reject any and all offers.
- 4. OWNERSHIP OF MATERIALS: The successful bidder, upon notification of award, shall become the owner of the material in accordance with the terms of the sale and subject to payment of the bid price in the manner specified. The University of Kentucky will regard property not removed within the specified time as having been abandoned and will have the right to dispose of such property as its own.
