



| 1. | Do you have a budget range you are looking for? | \$40-\$50k |
| 2. | I am inquiring if there is any original ground information on this area or if we are allowed to survey it ourselves to aid in the design of the project? | There are no Geotech reports of the area that is in the scope of project. Contractor can do such investigation or survey at own expense. Please submit to UK your plan is before completing. |
| 3. | We are assuming that uncovering the headwall that was buried at some point and creating a channel to tie into existing channel by soccer pitch is the only work associated with this RFP. Because of the unknowns regarding the pipe being clogged or not functioning for other reasons, we are assuming that any work that would happen to get this pipe to function again would be in addition to this RFP. Is this correct? | Correct. The scope starts with the requirement to expose the headwall and in corporate the Head wall and it's outflow into the mitigation area. Any restoration of the storm pipe will be outside the scope of the project. |
| 4. | In item 2.1 the RFP states that some work will be done to improve the utility and appearance of up to eight headwalls.
