2	How many references are required and what client information should be provided?	Three references should be sufficient. Client contact information should be provided for follow up.
3	Is an architectural and design firm already selected?	We have no architectural and design firm already selected.
4	Please provide the volume of the conditions treated in urgent care and ED including BHG and SUD.	This information will require a signed Business Associate Agreement and can be provided after the award of the contract.
5	Can you clarify your intention for this campus? Is the plan to expand the current facility, build a new (replacement) facility, optimize and reconfigure the current facility or something else?	Expansion in some form on the current campus is the intent. There is no plan to build a replacement facility.
6	Please explain 4.6.2 regarding service lines offered. Are you referring to clinical service lines (i.e. cardiology and oncology) or consultative services (i.e. planning, assessment)?	Clinical Service Lines

7	Can you provide further definition and examples of coalitions and special arrangements?	The University of Kentucky owns King's Daughters Medical Center.
8	How will the consultant be expected to provide input on the facility's renovation/addition programming and design? If the firm does not provide design services, can they partner with the selected architectural firm or propose a partnership with a design firm?	The successful offeror will work with the KDOH stakeholders after the RFP is awarded. If the firm does not provide design services, they may partner with an architectural firm.
9	Is there an overall plan by the system to significantly enhance KDOH'S service complement, including but not limited to development of collocated medical office building, enhanced ancillary and/or long- term or specialty care services that should be accommodated in planning the facilities and campusbeyond organic growth projections for current and identified gap needs?	This overall plan is to primarily review ED/UCC services and community need. The intent will be to build a plan off the identified needs. There are no current plans for medical office buildings or other services currently.
10	Can you provide clarity on the clinical service lines that KDOH offers? a. Are there specialty service lines that are to be investigated for "fit" with this location/campus (e.g., cancer center, physical rehabilitation, behavioral health/adolescent care)?	KDOH offers inpatient services as well as surgical services. We are not currently investigating any specialty service lines.
11	Are pediatrics/adolescent services provided (besides emergency care)? a. Are these a focus for consideration/expansion?	We provide pediatric/adolescent services through the ED/UCC. Yes, this is a focus as a significant portion of our ED/UCC volume comes from pediatrics.
12	Are there other UK King's Daughters affiliates (acquisitions and/or developments) that will impact our planning work with you on KDOH? Please explain	There are no other UK King's Daughters affiliates that will impact future planning.

We have not secured an architectural firm for use at KDOH. The stakeholder group will be decided by administration in collaboration with the company awarded the contract. If and when an architect would be involved, it will be on an ad hoc basis with the stakeholder group.
