### 1. INVITATION

Sealed proposals for the following work will be received by UK King's Daughters Medical Center, Department of Supply Chain Operations, Medical Arts Building, 2301 Lexington Avenue Suite 310, in the manner and on the date hereinafter specified for the furnishing of all labor, materials, supplies, tools, appliances, equipment, services, etc., necessary for the construction of PROJECT: <a href="UK King's Daughters HVAC Unit Installation, Medical Office Building A">UK King's Daughters HVAC Unit Installation, Medical Office Building A</a>, as set forth in the specifications and as shown on the drawings for as prepared by UK King's Daughters Department of Plant Operations and approved by the Department of Supply Chain Operations and under the terms and conditions of this Invitation.

## 2. PROJECT DESCRIPTION

The UK King's Daughters HVAC Unit Installation, Medical Office Building A will be managed by UK King's Daughters Medical Center Facilities Construction Manager. The project is generally described as:

- The demolition and removal of associated duct work for UK King's Daughters Pain Center Suite
- Installation of new ductwork and HVAC roof unit for UK King's Daughters Pain Center Suite
- Installation of new split system indoor unit and new split system outdoor unit for UK King's Daughters Oncology Suite
- The demolition and removal of associated duct work for UK King's Daughters Mechanical Room
- Installation of new ductwork and HVAC for UK King's Daughters Mechanical Room

#### 3. METHOD OF RECEIVING BIDS

Bids will be received from Contractors on a Lump Sum Amount for the total project. All phases of the work shall be bid to and through the Contractors. Bids shall be submitted in the manner herein described and on the official proposal form included with the conditions and specifications and shall be subject to all the conditions as set forth and described in the Bid Documents. Bids shall be submitted only on the Official Forms supplied by UK King's Daughters Medical Center, Supply Chain Operations. Failure to comply with the foregoing requirements will be cause for invalidation of bid.

#### 4. METHOD OF AWARD

Awards shall be issued on the best value responsive bid by a responsible bidder as determined by UK King's Daughters Medical Center and meeting all requirements of this solicitation.

### 5. SCHEDULE OF PROJECT

The time for completion of this project will be sixty (60) business days (pending material availability) beginning at the issuance of Notice of Awards to the successful General Contractor, which is anticipated to be issued on October 25, 2023. Final Completion shall be obtained no later than sixty (60) business days from start of construction. Upon receipt of the Notice of Award, the General Contractor shall provide working durations for each major portion of the Work to the Construction Manager. Prior to the execution of the Contract, the Construction Manager will review and approve the durations provided by the General Contractor. Liquidated Damages shall be assessed in the amount of \$500.00 per calendar day the project fails to reach Final Completion.

### 6. <u>BONDING</u>

A 5% bid bond or certified check equal to 5% of the bid will be required for all projects exceeding \$40,000, including all alternates, and is to be submitted with the official form of proposal.

A 100% payment and performance bond shall be executed for the full contract value of the base bid and any alternates accepted for all projects exceeding \$40,000.
