This Invitation for Bids is to allow interested parties to submit a bid for the sale of a used Bruker Ascend 400WB NMR Micro-Imaging Magnet System. The University is selling this system of instruments as is. This system of instruments is currently owned by the University of Kentucky, Lexington, Kentucky.

From the original posted IFS, the following replaces Paragraph Four on Page Four.

Specific Details

This system of instruments is no longer under warranty, there are no additional warranties or maintenance service contracts tied to this system. Potential buyers will be required to remove this system under their own means, during regular business hours, from the Todd Building, while keeping the building and its features intact. All financial obligations reside with the buyer when it comes to de-magnetizing, uninstalling, packing, moving, and loading this system onto a truck. This system is located down a basement corridor, and once the magnet weighing an estimated 1000lb, which stands roughly 8ft tall is de-magnetized, it will need to be crated or placed on a pallet and maneuvered down the corridor. The consoles, which are on wheels & additional accessories will also need to be crated, packed in boxes, or placed on a pallet and maneuvered down the corridor. A loading dock is available; however, the successful buyer will need to provide all material handling equipment, and essentials needed for moving and packaging, i.e., forklift, pallet jacket, crates, pallets, boxes, stretch wrap, strapping, tape. The university will not be providing any material handling equipment, assistance with maneuvering or packaging materials. The university, along with the College of Pharmacy will only be facilitating this move by providing the appropriate staff on hand to ensure all OSHA regulations, and any and all safety regulations the university has in place are followed. The awarded bidder will need to provide proof of insurance (COL) before removal, coverage requirements are below. If the awarded bidder was to utilize a rigger, the rigging service must provide proof of insurance (COL) before removal, coverage requirements are below.
